# Ethnic Politics Sociology 144 Professor G. Cristina Mora MW 4:00-5:30

#### Overview

This course surveys the experiences and political development of racial and ethnic groups in the United States. The course will be divided into two main sections. In the first section, we will review the historical trajectory of nation's four main racial/ethnic groups – African Americans, Latinos, Asians, and Native Americans – and consider how sociological understandings about race, ethnicity, assimilation, inequality, and mobilization can be used to describe these groups' political development. In the second section we consider how four main institutions – prisons, media, political parties, and immigration – have further shaped the political participation of these groups. The class ends with a discussion of post-racial visions of American politics, as well as an analysis of how race/ethnicity impact the current 2012-election season.
