SOC 102 SOCIOLOGICAL THEORY II

In this course, we will discuss the works of major late 20th century theorists, their analyses, the methodologies they use and their social prescriptions. How do they study social processes? What are their major findings and arguments? How does the social world work? How can society be improved? We will look at how functionalists, phenomenologists, poststructuralists, neo-Marxists, and practice theorists have answered these questions in conflicting ways.

After completing two thirds of the course, we will ask: how does all of this theorization apply outside of mainstream western society? This will bring us to theories of race, gender, and postcolonialism. Class and section discussion will highlight how we might use these theories to think about our own lives and recent events and processes.

You will write two midterm papers (5 pages each) and one final paper (8 pages) for this course. More specific guidelines about the papers will follow.
